## **Terms & Conditions of Entry**

**Applications and Final Payment COB 1 February 2017**

### **Terms and Conditions of Entry:**

Entry fees are subject to variation depending upon insurance costs. The information below will assist you in applying for an Invitation to Compete and in determining the acceptability of your vehicle. Please carefully read all information provided. The application form is designed to provide event organisers with all necessary detail regarding your entry. The information you provide may also be included in publicity material for the event.

### **Please observe these points:**

Complete EVERY detail as requested. Without full details of the crew and the vehicle, organisers will not be able to classify the car and may be unable to issue a final Invitation to Compete. Failure to provide complete and accurate information, particularly regarding modifications to your vehicle, may result in your application not being considered. Any invitation issued on false information may be rescinded with fees forfeited, and/or competitors may be excluded from all results.

Front and rear ¾ colour photographs of the nominated vehicle must be supplied to confirm the make and model. These must be good quality colour prints (black and white images are not suitable). If you wish to nominate more than one entry, please submit a separate application form for each vehicle with a separate AUD\$250 application fee for each. All applications will be considered by the Targa North West Vehicle Selection Committee and entries will be selected to create a field of the most desirable vehicles nominated to build a field of up to 100 cars.

**The below points should ultimately be read in conjunction with the Supplementary Regulations for Targa North West 2017. In the event of conflict, the Supplementary Regulations take precedence:**

Applications are to be lodged with the organisers by submitting the electronic forms supplied. Applications must specify the vehicle in which the applicant has nominated to compete listing the exact year the vehicle was built and full details of ALL modifications made to the original specifications of the vehicle. Each application must be accompanied by an application fee of AUD\$250 (fee is non-refundable).

Invitations to Compete (including for entrants eligible for Early Bird discount) will be issued by the organisers at their discretion. Any such invitation applies only to the nominated entrant, the nominated driver and the nominated vehicle as described in the "Vehicle Specifications" section of the application. An entrant wishing to change the vehicle originally nominated, or to vary its specifications in any way after an Invitation to compete has been issued, must notify the organisers. Organisers reserve the right to withdraw the original invitation and consider the proposed replacement vehicle as a new application at their discretion. Organisers reserve the right to decline an Invitation to Compete (including Early Bird applicants) in Targa North West 2017 without reason. The maximum number of starters is limited by road closure arrangements and, under current circumstances, will not exceed 100 vehicles for the competition. Following the lodgement of an application and the issue of an Invitation to Compete, the entrant, driver and navigator will be required to complete the Entry Form provided by the organisers.

An initially declined application may later be accepted subject to the approval of the body issuing the permit to conduct the event. It is a condition of entry that, from the completion of each vehicle's pre-event scrutiny, the vehicle is subject to Parc Ferme conditions as set down in the Supplementary Regulations. The entrant agrees all film and video tape rights for the event are jointly the property of the organisers, Targa Australia Pty Ltd, and Southern Cross Television. Competitors are permitted to carry video cameras in their vehicles for the purpose of making moving or still picture records for their private viewing but the organisers retain copyright of all film and video footage associated with the event. No movie, film or video taping of any part of the event shall be carried out by entrant or crew member other than with the express approval, in writing, prior to the commencement of the event by the organisers.

Any commercial arrangements made by the entrants and crew members for the sale of film or video/still footage, or viewing of such footage in a public place, must be approved in writing by the organisers. Entrants and crew members are advised to contact the organisers prior to making commitments for any such commercial arrangement. Failure to observe this regulation may lead to legal action by the organisers for a breach of copyright.

All crew members agree to the use in perpetuity of their names, photographs and photographs of their vehicles in publicity materials issued by the organisers or the event sponsors. Crew members further agree to comply with all film and video regulations. All crew members agree that their names and contact details may be made available to and be used by sponsors and licensees of the event. The organisers retain the right in perpetuity to authorise the production, distribution and sale of models, photographs or other forms of reproduction of any vehicle participating in the event, for any event-related promotions. Applications may be submitted post close of applications on 1<sup>st</sup> February 2017 but will incur an additional fee of \$150. No application will be accepted after 7<sup>th</sup> February 2017.

The Entry Fee will include the following items in all sections:

- Tickets for two crew members to the Welcome Party
- Lunches for two crew members on the day of the competition

**Additional Crew Members:**

Additional crew members may be nominated as replacements during the event but the nomination must be submitted online using the correct form. Acceptance of the nomination will be at the discretion of the organisers. For example, to cover the costs of merchandise, function tickets and administration, a fee of AUD\$150 will apply for each additional person nominated for each vehicle. This additional fee may be reduced or waived at the discretion of the organisers.

If, for any reason, an entrant fails to utilise an amount in the entry fee allocated for variable costs such as merchandise, function tickets and scrutiny, the balance shall be regarded as administration costs borne and will therefore be retained by the organisers. If any Entry Fee is not received within the specified time, the organisers reserve the right to withdraw the Invitation to Compete and allocate the vehicle competition number to another invited applicant. Entry fees are subject to variation depending upon insurance costs.

**Withdrawal and Refunds:**

An applicant whose application is rejected will have the amount of monies paid as a deposit refunded. An applicant who applies to compete and who then withdraws from the event will incur a \$250 withdrawal fee and will be able to transfer their remaining funds without to another Targa Australia event within one year of the date of the originally entered event. If not utilised in this period, all paid funds will be forfeited.

**Targa Tasmania 2017 Competitors OFFER**

- This offer is only applicable to Targa Tasmania 2017 entrants and can only be utilised if the same driver, navigator and/or co-driver and vehicle are entered in both events. This offer cannot be transferred and used at any other Targa Australia events.
- The full applicable entry fee for the Targa North West 2017 event remains payable within the normal terms and conditions.
- If a competitor has paid in full including all associated costs, levies and insurance and starts the 2017 Targa Tasmania, a credit of the applicable 2017 Targa North West entry fee will be refunded to the competitor during the running of Targa Tasmania 2017.
- All other associated costs, levies and insurance applicable to Targa North West 2017 are not refundable or transferable in any way.
