

## **Targa High Country 2019 Competition – Win a free entry**

### **HOW TO ENTER**

To be eligible, entrants must enter into Targa High Country 2019 between Friday 7<sup>th</sup> June and Sunday 30<sup>th</sup> June and pay a \$500 deposit or already be entered prior to competition start date. The winner will be announced on our website within 24 hours of the competition being drawn. The winner will also be notified by email within 24 hours of the competition and their name and town or city of residence may be announced via electronic correspondence and/or social media pages.

### **CONDITIONS - PARTICIPATION**

1. This competition ("Competition") Targa Australia 79 0924 389 92 ("Promoter").
2. Entry to the Competition constitutes acceptance of these conditions. All entry instructions and prize information published by the Promoter form part of these conditions.
3. The Competition is only open to Eligible Entrants. An "Eligible Entrant" is an individual who: (i) participates by entering via [targa.com.au](http://targa.com.au) and pays a \$500 deposit, (ii) meets all competitor eligibility criteria and is offered an invitation to compete.
4. Competition entry opens at 1:00pm on Friday 7 June 2019 and closes at 9:00pm on Sunday 30 June 2019 ("Entry Period").

### **ENTRY GENERAL**

5. Competition entry is limited to one entry per individual.
6. All entries to the Competition may be subject to verification by the Promoter.
7. The Promoter may, at its absolute discretion, declare any or all entries made by an entrant invalid if the entrant: (i) fails to establish their entitlement to enter the Competition to the Promoter's satisfaction; or (ii) fails to produce items as required by condition or produces items that, in the Promoter's opinion, are illegible, stolen, forged, reconstructed, altered, incomplete or tampered with in any way; or (iii) in the Promoter's opinion, tampers with the entry process or benefits from such tampering; or (iv) in the Promoter's opinion, submits an entry which is not in accordance with these conditions.

To the full extent permitted by law, the Promoter, its associated companies and agencies and all those entities' personnel (the "Relevant Parties") exclude all liability for any loss (including any damage, claim, injury, cost or expense) which is suffered or incurred by any Eligible Entrant through use of the prize, including: (i) any indirect, economic or consequential loss); (ii) any loss arising from the negligence of a Relevant Party; (iii) any liability for personal injury or death.
